

## MINUTES OF MEETING

A meeting was held on 23/08/17 at 1500 hrs at DC's chamber with the bank managers of west Siang District to discuss various issues relating to banking and for smooth provision of loans to the interested entrepreneurs, weavers and farmers under CM's flagship Scheme such as **Deen Dayal Uphadayayaya Swalamban Yojana, Chief Minister's Krishi Rinn Yojana and Deen Dayal Uphadyayaya Bunkar Yojana**. The meeting was chaired by Ms. Swetika Sachan, IAS, Deputy Commissioner, West Siang District Aalo.

The members present in the meeting is appended.

At the onset the chairman welcomed the members and briefed the objective of the meeting. She highlighted that the applicants for grant of loan under the various CM's Flagship Programme are confused and facing problem in applying for the loan due to lack of coordination. Hence, she requested to come up with proper procedure to apply for the loan under various CM's Flagship Programme.

After threadbare discussed the following points were agreed upon unanimously by the members present.

1. To strengthen and keep track & record of the no. of applicants it was decided that all the applications have to be submitted in the respective Administrative Officer of the subdivision i.e. ADC's Office & Office Likabali. The application submitted has to be forwarded to the concerned banks by ADC's & SDO Likabali respectively weekly and the same has to be displayed on the notice board of the respective officers for the knowledge of the applicants.

2. The Administrative Officer have to give monthly report to the Deputy Commissioner, West Siang District, regarding the no. of applications forwarded to bank.

Action by Administrative Officers.

3. The respective branch manager have to give monthly report regarding the number of loan sanction & name against who loan has been sanction to the Deputy Commissioner, West Siang District.

Action by Bank Manager.

4. The Lead Bank Manager have to produce the non defaulter Certificate of the applicants in the District Screening Committee for Deen Dayal Uphadyayaya Swalamban Yojana.

Action by Bank Manager.

5. The Bank Manager SBI, informed that CSP's has been deputed in Non-Banking circles. The DC directed that none of the Circles should be left unbanked. She also directed that outreach programmes should be done for Aadhar Seeding of the Bank Accounts.

Action by Administrative Officer & Bank Manager.

6. The Bank Manager, SBI highlighted that acute problem are faced due to connectivity problem. In this regards the Chairman highlighted that their has been constant reminder for better connectively from her end.

7. The Bank Manager's also highlighted that the subsidy amount due to be received from the Govt. in respect with PMEGP for the year 2013 & 2016 has not yet been received. In this regard the chairman directed to the concerned Bank Managers to give in writing the detail status so that the matter can be pursued with the appropriate authority.
