::ORDER::

Whereas, with a view to ensure peaceful conduct of the ensuing Panchayat Election, 2013 to be held on 16/05/2013, it has been considered necessary to temporarily suspend all the licenses of possession of all the Arms & Ammunition in West Siang District from last date of withdrawal of nomination i.e. 29/04/2013.

Therefore, I, Manoj Kumar Sahoo, District Magistrate, West Siang District, Aalo, in exercise of power conferred upon me U/S 4 read with Section 17(3)(b) of Arms Act, 1959, do hereby suspend the Arms & Ammunition Licenses of West Siang District and direct all license holders of all type of fire Arms to deposit their weapons with the Officer in-Charge, Police Station of their respective jurisdictions latest by 28/04/2013.

Superintendent of Police, West Siang district is directed to issue instructions to officer-in-charge of Police Station to take into custody Arms & Ammunition possessed by license holders during the period of suspension of license.

Thereafter, the Administrative Officers should conduct intensive drives to collect/seize Arms from all villages and town areas. If any Arms holder ignores/violate above Order, it shall be considered sufficient ground for cancellation of license and seizure of Weapons.

However, the Govt. Officers/Department and Banks would be exempted from the purview of this order. All weapons with license shall be released on 25/05/2013 if not otherwise directed by the court.
