O R D E R

The General Election to the Panchayats, 2013 is scheduled to be held on 16.05.2013. In this regard all the printing press situated in West Siang district are directed to adhere to the following guidelines for restrictions on the printing of pamphlets, posters etc. for election purposes

As per the **Section 127 of the Representation of the People Act, 1951: Restriction on the printing pamphlets, posters etc.** (1) No person shall print or publish or cause to be printed or published, any election pamphlets or posters which does not bear on its face the names and address of the printer and publishers thereof.

(2) No person shall print or cause to be printed any election pamphlets or posters.

(a) Unless a declaration as to the identity of thereof, signed by him and attested by two persons to whom he is personally known, is delivered by him to the printer in duplicate, and

(b) Unless, within a reasonable time after the declaration is sent by the printer, together with one copy of the document,---

(i) where it is printed in the capital of the State, to the Chief Electoral Officer, and

(ii) in any other case, to the District Magistrate of the district in which it is printed.

(3) For the purposes of this section, ---

- (a) any process for multiplying copies of a document, other than copying it by hand, shall be deemed to the printing and the expression "printer" shall be construed accordingly; and
- (b) "election pamphlet or poster" means any printed pamphlet, hand-bill or other document distributed for the purpose of promoting or prejudicing the election of a candidate or group of candidates or any placard or poster having reference to an election, but does not include any hand-bill, placard or poster merely announcing the date, time place and other particulars of any election meeting or routine instructions to election agents or workers.
- (4) Any person who contravenes any of the provisions of sub-section (1) or sub-section (2) shall be punishable with imprisonment for a term which may extend to six months, or with fine which may extend to two thousand rupees; or with both.

In view of the above provisions, you are hereby requested to print the names and addresses of the printers and publisher on the face of any election material and send two copies of the same to this office.
