**ORDER**

Whereas due to the situation prevailing in the West Siang District because of the ensuing General Election to Panchayats'2013, it is apprehended that anti-social elements may seek hideouts in different areas of the District and there is every likelihood of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety and injury to public property on that account.

And, whereas it is necessary that some checks should be put on Landlord/Hotel/Guest House/ Lodge so that anti-social elements in the guise of tenants / visitors/guests may not disturb public peace and for that immediate action is necessary for the prevention of the same.

Now, therefore, I, Manoj Kumar Sahoo, District Magistrate, West Siang in exercise of the power conferred upon me by **Section 144 of Code of Criminal Procedure, 1973**( No. 2 of 1974), do hereby order that no Landlord / Hotel / Guest House / Lodge shall let/sublet/rent out any accommodation to any persons unless and until he has obtained the copy of any reasonable document of identity proof (like Election I.D. card, PAN Card, Driving Licence, Passport, Credit Card or Debit Card and any other reasonable proof of identity) of the said tenants / visitors/ guests and unless and until he has furnished the particulars of the said tenants / visitors/ guests to the In-charge of the Police Station/ Outpost concerned. All persons who intend to take accommodation on rent shall inform in writing in this regard to In-charge Police Station/ Outpost concerned in whose jurisdiction the premise falls.

This order shall come into force with the effect from 19/04/2013 and shall be effective for a period of 60 days i.e. up to 16/06/2013 (both days inclusive) unless withdrawn earlier. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.

As the Notice cannot be served individually to all concerned, the order is hereby passed ex-parte. It shall be published for the information of public through Press and by affixing copies on the notice board of the offices of all Offices of West Siang including the office of the Superintendent of Police, Additional Superintendent of Police, all Police Stations/Outpost and the offices of the Zilla Parishad/ Anchal Samiti and Gram Panchayats of West Siang District.
