PRELIMINARY NOTIFICATION

WHEREAS, the powers and functions of the appropriate authority under the Land Acquisition Act, 1894 vested in the Governor, Arunachal Pradesh and which shall be exercised and discharged by him within the State.

AND WHEREAS, it appears to the Governor of Arunachal Pradesh that an area measuring 1762468.5 Sqmtrs.(176.24 Hectares) is likely to be needed for the construction of Tato-II Hydro Electric project at West Siang District, Arunachal Pradesh.

AND NOW THEREFORE, this notification is made under provision of section 4(1) of Land Acquisition Act, 1894 (Act No.1 of 1894) to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorize the Officers & officials for the time being engaged for the said purpose with their Servants and Workmen to enter upon and survey any land and to do all other acts in pursuance of the provisions of sub-section (2) of the above section.

Any person interested in the said land and who so ever has any objection to the acquisition of the land may within 30(thirty) days from the date of publication of this notification file such objection in writing before the Deputy Commissioner, West Siang District, Aalo, Arunachal Pradesh.
